

MEMORANDUM FROM THE CONGOLESE COMMUNITY IN THE UNITED KINGDOM ADDRESSED TO HIS EXCELLENCY THE BRITISH PRIME MINISTER

CONGOLESE COMMUNITY 2/24/2024





Your Excellency the Prime Minister,

We, British people of Congolese origin, come very respectfully under your high authority to submit to you this memorandum on the security situation in the Democratic Republic of Congo (DRC).

- 1- Since 2006, the Congolese had already understood the strategy of the war of aggression that is being unjustly imposed on the DRC;
- 2- The wounded Congolese had found the right words to express their deep feelings through several international meetings;



- 3- The Congolese do not understand the exact position of the member countries of the international community;
- 4- Former French President Nicholas SARKOZY had openly called for the DRC to be able to share its mineral resources with its neighbours;
- 5- Is the unjust war imposed on the DRC through the veiled face of the multinationals of the countries of the International Community through Rwanda, the logical continuation of the words of former French President Nicholas Sarkozy?
- 6- On Tuesday 09.05.2023, the Ambassador of the European Union (EU) Mr Jean Marc CHANTAIGNÉ had made a statement confirming the sovereignty of the DRC over its minerals and the inviolability of its borders;
- 7- The U.S. Embassy in the DRC has published a document whose content appears to follow the statements of the EU Ambassador, Jean Marc CHANTAIGNÉ;
- 8- But what astonishes and surprises any man who loves PEACE and JUSTICE is the discrepancy between the declarations and the real situation of consideration that the Americans and the European Union are sending Poland (member of NATO and the EU) next to Rwanda to attack the DRC;
- 9- Despite multiple proofs of the presence of the Rwandan army in the DRC, the international community continues to provide military support to Rwanda;
- 10- UN Secretary-General Antonio Guterres said that MONUSCO (United Nations Organization Mission for the Security of Congo) was not capable of fighting the M23, which he said had more sophisticated weapons;
- 11- The Congolese know that the countries of the international community have factories for the manufacture of sophisticated weapons;
- 12- So the international community knows very well the origin of these weapons and who was transporting them to the M23 through Rwanda;
- 13- It is an open secret that Paul KAGAME, after shooting down the plane in which two presidents of Rwanda and Burundi were killed, himself perpetrated the genocide of the Tutsis under the complacent eye of France and the international community;



- 14- The international community has poured into the DRC the armed men of Rwanda and that they are today the business of the multinationals of the countries of the international community to be the veiled face of Paul Kagame and the M23;
- 15- Having understood that the Congolese will never agree to negotiate with the M23, the multinationals of the countries of the International Community have just created the AFC (Congo River Alliance) with Mr. Corneille NANGA, former president of the CENI (Independent National Electoral Commission), to transfer all the M23 fighters to the AFC and ask the Congolese to negotiate with this renovated M23 AFC;
- 16- What is even more serious is the action taken by the British Government, which you have the honour to lead, to send mercenaries to Rwanda under cover of refugees, men without children and women to reinforce the aggression of the DRC through this unjust and barbaric war imposed on the DRC;
- 17- There have also been campaigns maintained by the multinationals of the countries of the International Community which consisted of grouping together certain individuals qualified as Tutsis of the DRC to claim entire Congolese territories in order to balkanize the DRC through a referendum;
- 18- Thus, these multinationals from the countries of the international community could find a propitious opportunity to balkanize the DRC;
- 19- What would be the reaction of the British people if they learned that the British people of Congolese origin were claiming Tottenham in London as a land that should belong to them because of their large numbers in this part of British soil, especially since the majority of us were accepted as refugees before we became British?



Your Excellency the Prime Minister,

Being the British of Congolese origin, we come under your high authority in full respect of the laws of our country, the United Kingdom, to propose the following:

- 1- Our country, the United Kingdom being a member of the Security Council, should by its right of veto prevent any attempt to dismember the DRC;
- 2- Our country, the United Kingdom, should ask NATO and the European Union to withdraw Poland from Rwanda;
- 3- Our country, the United Kingdom should stop and abandon the sending of disguised mercenaries to Rwanda.
